<b>What is the overall deductible?</b>	\$1,500/person or \$3,000/family for In- <u>Network</u> Providers. \$3,000/person or \$6,000/family for <u>Out-of-Network</u> Providers.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your deductible?</b>	Yes. Primary Care. <u>Specialist</u> Visit. <u>Preventive Care</u> . For more information see below.	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. <b>What is the out-of-pocket limit for this plan?</b>	\$2,500/person or \$5,000/family for In- <u>Network</u> Providers. \$5,000/person or \$10,000/family for <u>Out-of-Network</u> Providers. This plan has a separate Out of Pocket Maximum for pharmacy services of \$4,350/person or \$8,700/family for In- <u>Network</u> Providers and Unlimited for Non <u>Network</u> Providers.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services.
